



**RESOLUTION
OF THE COUNCIL
OF VILNIUS UNIVERSITY**

**ON THE APPROVAL TO EXPAND THE BOUNDARIES OF VILNIUS UNIVERSITY
TERRITORY BY PURCHASING REAL ESTATE WITH PART OF THE LAND PLOT
LOCATED IN BIRUTÈS AL. 35 AND 37, PALANGA, FROM A CO-OWNER**

In accordance with Articles 3(3), and 38(1)(9) of the Statute of Vilnius University and Items 12(1) and 13 of the Description of the Procedure for the Use of Funds and the Management, Use and Disposal of Assets of Vilnius University, approved by Resolution of the Council of Vilnius University No. T-2017-2-10 of 7 April 2017 “On the Approval of the Description of the Procedure for the Use of Funds and the Management, Use and Disposal of Assets of Vilnius University” (as amended by Resolution of the Council of Vilnius University No. TPN-19 of 29 November 2023), taking into account Article 88(1)(5) of the Republic of Lithuania Law on Higher Education and Research, Proposal from the Rector of Vilnius University No. RTK-20 of 18 March 2026 “On the Approval to Expand the Boundaries of Vilnius University Territory by Purchasing Real Estate With Part of the Land Plot Located in Birutės al. 35 and 37, Palanga, from a Co-Owner”, and Resolution of the Senate of Vilnius University No. SPN-12 of 17 March 2026 “On the Approval to Expand the Boundaries of Vilnius University Territory by Purchasing Real Estate With Part of the Land Plot Located in Birutės al. 35 and 37, Palanga, from a Co-Owner”, and in order to meet the increasing infrastructure needs of Vilnius University community for carrying out academic activities, the Council of Vilnius University

hereby decides:

1. To approve the expansion of the boundaries of Vilnius University territory by purchasing assets possessed by the right of ownership by a co-owner, consisting of:
 - 1.1. Recreational building, unique number 2593-0000-5011, total area 419.81 sq. m, located in Birutės al. 35, Palanga, ½ share of the building,
 - 1.2. Recreational building, unique number 2593-0000-7017, total area 535.29 sq. m, located in Birutės al. 37, Palanga, ½ share of the building,
 - 1.3. Land plot, designation – other, unique number 2501-0031-0094, located in Birutės al. 35, Palanga, parts 2959/17491.
2. To establish that the purchase price of the property indicated in Item 1 of this Resolution cannot exceed the value of the property established in accordance with the Republic of Lithuania Law on the Bases of Property and Business Valuation by more than 10 per cent.
